Should I trespass and violate this oath, may the reverse be my lot !





Ragging is Banned in the College and Hostel Premises

According to the ruling of the Hon'ble Supreme Court of India. "In case the applicant for the admission is found to have indulged in ragging in the past or if it is noticed later that he has indulged in ragging. Admission may be refused or he/she shall be expelled from the education institute."

Any Student of Institute of Education and Technology found involved in ragging or outside the college/hostel shall be punished heavily with a fine up to Rs. 50,000/- and may also be expelled from the college with immediate effect without any notice.



DISCIPLINE AND CONDUCT

Student / Parents / Guardians are specifically requested to note the discipline rules of the Institute and the code of conduct for the students fo IET Society's Institute of Education and Technology.

- 1. The student must be absolutely regular in his/her attendance for theory and practical classes. In case the students attendance is less than 75% at the theory lectures and the practicals separately, his/her term will bot be granted. In case of genuine reason the students or his/her guardian mus inform to the authorities of the institute about the reason of remaining absent.
- 2. The student must be present for all the tutorials and the guest lecture.
- 3. The student name will be struck off from the roll call if he/she remains absent for more than one month without prior written notice.
- 4. The student should complete all the term works such as journals or any other assignment as per schedule in the prescribed time.
- 5. The student should note he/she is responsible to the authority of the Institute behavior outside. Violation of the Institute rules or any act of indiscipline within the campus will make him/her liable for the strict disciplinary action.
- 6. The student should not participate in any political or antisocial activities. No person shall be invited to address any meeting without the prior permission of the Principal in writing.
- 7. Smoking, drinking, use of drugs, gutka, chewing gum etc. in the Institute permises and campus is strictly prohibited.
